

Top 10 Out of Service Violations for Nevada Motor Carriers (nationwide)

A critical sub-set of roadside violations are those that put the driver or vehicle out of service. Identify these for immediate action within your fleet to make a difference in your safety performance and public-facing safety scores.

Preventable or Non-Preventable? That is the Question...

The American Trucking Associations' Preventability Guidelines help determine whether a truck crash could have been avoided by the driver or company. Below are examples of preventable and non-preventable crash scenarios based on these guidelines.

A crash is considered **preventable** if the truck driver or company could have reasonably avoided it through better judgment, defensive driving, or proper vehicle maintenance.

1. Rear-End Collision

- Scenario: A truck driver follows too closely and is unable to stop in time when traffic suddenly slows down, crashing into the car ahead.
- Preventability: Preventable The driver should have maintained a safe following distance to allow for sudden stops.

2. Lane Change Crash

- Scenario: A truck driver changes lanes without properly checking blind spots and collides with a car in the adjacent lane.
- Preventability: Preventable The driver should have used mirrors, turn signals, and checked blind spots before changing lanes.

3. Loss of Control on Wet or Icy Roads

- Scenario: A driver is speeding in rainy conditions, hydroplanes, and crashes into a guardrail.
- Preventability: Preventable The driver should have adjusted speed for road conditions.

4. Crash Due to Mechanical Failure

- Scenario: The truck's brakes fail due to lack of proper maintenance, leading to a collision.
- Preventability: Preventable The trucking company or driver should have ensured routine maintenance and inspections.

5. Intersection Collision

- Scenario: A truck driver runs a red light and crashes into cross-traffic.
- Preventability: Preventable The driver should have obeyed traffic signals and slowed down.

A crash is considered **non-preventable** if it was caused by factors beyond the truck driver's or company's control.

1. Hit While Legally Parked

- Scenario: A truck is parked legally in a designated rest area, and another vehicle crashes into it.
- Preventability: Non-preventable The truck was parked safely and was not moving.

2. Rear-Ended by Another Vehicle

- Scenario: A truck is stopped at a red light and is hit from behind by a speeding car.
- Preventability: Non-preventable The truck driver had no control over the other driver's actions.

3. Sudden Medical Emergency

- Scenario: A truck driver suffers a heart attack while driving, causing loss of control and a crash.
- Preventability: Non-preventable If the driver had passed all required medical exams, the medical emergency was unforeseen.

4. Animal Strike

- Scenario: A large deer suddenly jumps in front of a truck on the highway, causing a crash.
- Preventability: Non-preventable The driver could not have reasonably avoided the collision.

5. Tire Blowout Due to Road Debris

- Scenario: A truck's tire blows out after hitting an unavoidable object on the road, leading to a crash.
- Preventability: Non-preventable If the truck was properly maintained and the driver could not avoid the debris, the crash was unavoidable.

Free Safety Tool: The FMCSA Safety Planner

The FMCSA (Federal Motor Carrier Safety Administration) Safety Planner is a free tool designed to help motor carriers understand and comply with federal safety regulations. It provides guidance on how to improve safety management practices and maintain compliance with FMCSA requirements.

Key Features of the FMCSA Safety Planner:

- 1. **Regulatory Compliance:** Offers information on FMCSA regulations, including Hours of Service (HOS), driver qualification requirements, vehicle maintenance, and hazardous materials transportation.
- Best Practices: Provides safety management techniques to reduce crashes, injuries, and fatalities involving commercial motor vehicles (CMVs).
- 3. **Customizable Guidance:** Allows carriers to tailor the planner to their specific operations and compliance needs.
- 4. **Inspection and Audit Preparation:** Helps carriers prepare for roadside inspections, compliance reviews, and safety audits.
- 5. **Safety Improvement Strategies:** Recommends policies and procedures to enhance fleet safety and minimize violations.

This planner is especially useful for motor carriers, safety managers, and compliance officers looking to maintain a safe and legally compliant operation under FMCSA regulations.
